### **Nonresident Teaching**

Developed and coordinated national & international natural resource enterprises workshops, demonstrations, and web-based training for landowners, farmers, resource agency staff, and community leaders in business planning, marketing, and associated land & water habitats management practices for initiating and operating fee-access recreational enterprises on private lands & waters.

Accomplishments include:

Conducted nearly 125 nationally and internationally-held workshops, field demonstration days, and conferences from 2005-present in Alabama, Arkansas, Indiana, Michigan, Minnesota, Mississippi, Louisiana, Oregon, South Carolina, Tennessee, and Texas drawing 5,500 participants, including 5,000 landowners. Events were hosted in U.S. states and in Sweden at the requests of sister state cooperative extension services, state & federal resource agencies, landowner trade organizations (e.g., farm bureaus), and the Mississippi Band of Choctaw Indians. Michigan State University Forestry Extension used the NRE Program to model a similar program in Michigan ([http://msue.anr.msu.edu/resources/natural\\_resources\\_enterprises](http://msue.anr.msu.edu/resources/natural_resources_enterprises)). Workshops are attended regularly by wildlife biologists, foresters, and loggers in participating states for credit toward certification in their representative professional associations.

Findings from the Natural Resource Enterprises Landowner 2010-2020 Survey mailed to past NRE workshop participants found 1,200 new NRE businesses had been initiated on nearly 3 million acres in 27 U.S. states due to programming. These businesses have generated an estimated \$22 million in additional cash flow to family incomes and improved conservation on 2 million private acres.

Developed multiple 400-800-page State Natural Resource Enterprises Educational Guidebooks (12 versions of binder in partnering states) with



collaborators for participants of workshops and demonstrations on fee-access recreational enterprise development and wildlife and fish habitat management on private lands. These resource binders were developed for Alabama, Arkansas, Indiana, Louisiana (northern LA and Coastal LA), Michigan, Minnesota, Mississippi (Interior MS and Coastal MS), Oregon, South Carolina, and Tennessee.

Developed educational curricula entitled Natural Resource Enterprise Development and Wildlife Habitat & Fisheries Management on Private and Tribal Lands tailored to collaborating U.S. states and Sweden. Curricula successfully implemented in NRE events in Alabama, Arkansas, Indiana, Louisiana, Michigan, Minnesota, Mississippi, Oregon, South Carolina, Tennessee, and Texas landowner workshops and field-day demonstrations.

In response to landowner demand, I developed advanced workshop curricula and 100-page educational binder of resources & materials for programming in NRE business model and plan creation, legal considerations in initiating an NRE business, social media and marketing planning for NRE businesses, and habitat and land management strategies for managing featured wildlife and fish species associated with NRE operations (fee hunting, birding and wildlife watching, fee fishing, and coastal outdoors tourism operations). Curricula implemented in successful workshops in Arkansas, Indiana, Louisiana, Mississippi, Oregon, and South Carolina.

Senior producer responsible for generating 87 land & water resource management and operational training videos and 6 online tutorials for landowners hosted on the NRE Homepage and website - [www.naturalresources.msstate.edu](http://www.naturalresources.msstate.edu) and YouTube Internet channel.

Developed and deployed 3 interactive websites (program website: [www.naturalresources.msstate.edu](http://www.naturalresources.msstate.edu)) for technology transfer to users, a geospatial marketing website for marketing fee-access lands and for enterprises offering outdoor excursions (Mississippi Outdoor Adventures), and a workshop online registration and marketing website. NRE Homepage generated nearly 600,000 sessions from 192 countries worldwide including the U.S. accounting for 300,000 page views from 2008-present; Visitors from the U.S. (all 50 states represented) accounted for 87% of overall website use with new visitors to the site representing 84% of volume while new visitors accounted for 16%.
